- Mayor J. Wall advised that this problem has been ongoing with Council and needs to be resolved. In reference to permits being given to resident's in contravention of the Town Plan, there is nothing we can do to reverse those decisions. Mayor J. Wall stated that the issue has been going on long enough and feels a resolution is in need as soon as possible.
- Deputy Mayor M. Vardy agreed and stated that by installing these culverts at the Town's initial expense, would not be precedent setting. This is a problem the Council has inherited from the previous Council, and the current Council would like to resolve it as efficiently as possible.
- Councillor K. Jordan advised that because the homeowners build their houses against the Town Plan, the Council should not pay for this. It should not be the Town's responsibility to install culverts.
- Councillor R. Brink advised that we have a letter from our Town Engineer stating deficiencies in the road, which is a stipulation in the approval of a permit for the resident developing the road.
- Mayor J. Wall stated that the people of the Town want to see this issue dealt with and resolved. HE feels that residents of the Town would rather see the most cost effective measure is taken.
- Councillor R. Tizzard stated that this is an issue between two residents not the Town.
 The Town's actions are based on advice from the Engineer.
