<b>DETAILS OF PROJECT:</b>	<ol style="list-style-type: none"><li>1. Excavation, supply of fill, and ground preparation for parking lot and pathway</li><li>2. Construction of parking lot at least 11m wide x 5.8m deep on Satellite Road</li><li>3. Construction of a paved pathway to swing from parking lot along the eastern property boundary to meet the requirements of an "Exterior barrier free path of travel" as per section 8 of the Buildings Accessibility Regulations under the Buildings Accessibility Act. Details to include:<ol style="list-style-type: none"><li>a. Be a continuous plane, uninterrupted by steps or abrupt changes in elevation, with a gradient not exceeding one in 20 (i.e. 5% grade)</li><li>b. No abrupt change in elevation greater than 6mm will be tolerated.</li><li>c. Be at least 1100mm in width.</li><li>d. Length will be approximately 39m.</li><li>e. No handrails or guards along the path are required.</li></ol></li><li>4. Paving of parking lot and pathway with asphalt of 50mm thickness over 100mm of compacted Class B stone and 100mm of compacted Class A stone</li><li>5. Parking lot to be graded to allow for adequate drainage</li><li>6. Painting, decals, posts, and signs are excluded from this scope of work</li><li>7. Site visit is required for contractors wishing to submit a bid</li></ol>
